**First Watch To Open in Summit Pointe**

First Watch also serves its socially responsible and award-winning Project Sunrise coffee, which supports an independent group of female farmers in Huila, Colombia.

"We are extremely excited to bring this award-winning concept to Summit Pointe," said Chris Williams, senior vice president with Summit Pointe Realty, LLC. "First Watch has a proven track record of providing a high-quality breakfast and lunch experience that we believe fits perfectly with our community."
